A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Electricians Act of 2020**

3 FOR the purpose of altering the composition, powers, and duties of the State Board of
4 Master Electricians; changing the name of the State Board of Master Electricians to
5 the State Board of Electricians; establishing a low-voltage electrician license as a
6 State license to be awarded to qualifying electricians; requiring the Maryland
7 Department of Labor to adopt regulations to establish the education requirements
8 and qualifications for a State apprentice electrician license and a State-registered
9 apprentice electrician license; prohibiting, beginning on a certain date, local
10 jurisdictions from issuing certain licenses under certain circumstances; authorizing
11 local jurisdictions that issued certain licenses before a certain date to continue to
12 issue the licenses under certain circumstances; prohibiting a certain local
13 jurisdiction, beginning on a certain date, from licensing a master-level or
14 journeyman-level electrician unless it applies for and receives authorization from
15 the State Board; requiring the Department to adopt guidelines to govern a certain
16 authorization process; requiring certain local jurisdictions to report certain
17 information to the Department on or before a certain date each year; allowing a local
18 jurisdiction to take certain actions against certain licensees under certain
19 circumstances; requiring certain local jurisdictions to administer a certain
20 examination in a certain manner; requiring each county and each municipal
21 corporation to enforce certain provisions of law and adopt certain regulations or
22 require certain State licenses under certain circumstances; altering certain licensing
23 and examination requirements; authorizing a local board to apply to be a certain
24 testing service; altering a certain provision of law stating that certain provisions of
25 law do not require certain individuals to hold a State license to refer to “low-voltage
26 electricians” rather than a “master electrician”; altering certain reciprocity
27 requirements for certain individuals authorized to provide electrical services in other
28 states; establishing certain continuing education requirements; authorizing the
29 State Board to waive certain examination requirements and certain experience
30 requirements for certain licensees in certain circumstances; altering the
31 circumstances under which the State Board may deny a license to an applicant,

1 reprimand a licensee, or suspend or revoke a license; authorizing the State Board to
 2 set certain fees; providing for the construction of a certain provision of law; requiring
 3 a master electrician to display certain information in a certain manner; requiring a
 4 licensee to give the State Board certain notice of a change in certain information;
 5 prohibiting a person from taking certain actions without a license; establishing
 6 certain penalties for certain violations; requiring the State Board to provide a certain
 7 notice to each local board in the State; altering, adding, and repealing certain defined
 8 terms; making stylistic and conforming changes; and generally relating to the State
 9 Board of Electricians and the licensing and regulation of electricians.

29 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 30 That the Laws of Maryland read as follows:

31 **Article – Business Occupations and Professions**

32 6–101.

33 (a) In this title the following words have the meanings indicated.

34 (b) (1) “Assignment of local license” means any procedure by which a licensee
 35 grants to another person a right to use a local license to enable that person to engage in the
 36 business of providing electrical services.

37 (2) “Assignment of local license” includes any procedure by which:

1 (i) a licensee agrees to be the representative of another person; and

2 (ii) by virtue of that agreement, the other person is authorized to
3 engage in the business of providing electrical services.

4 (c) “Engage in the business of providing electrical services” means to engage in
5 providing electrical services for compensation.

6 (d) **(1)** “License” means, unless the context requires otherwise, a license issued
7 by the State Board or a local jurisdiction to provide **OR ASSIST IN PROVIDING** electrical
8 services.

9 **(2) “LICENSE” INCLUDES, UNLESS THE CONTEXT REQUIRES**
10 **OTHERWISE:**

11 **(I) A MASTER ELECTRICIAN LICENSE; AND**

12 **(II) A JOURNEYPERSON ELECTRICIAN LICENSE.**

13 **(E) “LICENSED JOURNEYPERSON ELECTRICIAN” MEANS, UNLESS THE**
14 **CONTEXT REQUIRES OTHERWISE, AN ELECTRICIAN WHO IS LICENSED BY THE STATE**
15 **BOARD OR A LOCAL JURISDICTION TO PROVIDE OR ASSIST IN PROVIDING**
16 **ELECTRICAL SERVICES.**

17 **(F) “LICENSED LOW-VOLTAGE ELECTRICIAN” MEANS, UNLESS THE**
18 **CONTEXT REQUIRES OTHERWISE, AN ELECTRICIAN WHO IS LICENSED BY THE STATE**
19 **BOARD OR A LOCAL JURISDICTION TO PROVIDE LOW-VOLTAGE ELECTRICAL**
20 **SERVICES.**

21 **[(e)] (G)** “Licensed master electrician” means, unless the context requires
22 otherwise, a master electrician who is licensed by the State Board or a local jurisdiction to
23 provide electrical services.

24 **[(f)] (H)** “Local board” means a board that a local jurisdiction of the State creates
25 to regulate any aspect of the electrical trade.

26 **[(g)] (I)** “Local license” means, unless the context requires otherwise, a license
27 that is issued by a local board to provide electrical services as a master electrician.

28 **(J) “LOW-VOLTAGE ELECTRICIAN” MEANS AN INDIVIDUAL WHO HAS THE**
29 **EXPERIENCE, KNOWLEDGE, AND SKILL TO PROVIDE LOW-VOLTAGE ELECTRICAL**
30 **SERVICES IN A MANNER THAT COMPLIES WITH APPLICABLE PLANS,**
31 **SPECIFICATIONS, CODES, OR LAW.**

32 **[(h)] (K)** “Master electrician” means an individual who has the experience,

1 knowledge, and skill to provide electrical services in all aspects of the electrical trade, in a
2 manner that complies with applicable plans, specifications, codes, or law.

3 **[(i)] (L)** (1) “Provide electrical services” means to provide any service in the
4 electrical trade.

5 (2) “Provide electrical services” includes installing, repairing,
6 **MAINTAINING, ERECTING,** or altering any electrical **EQUIPMENT,** wiring, fixture,
7 appliance, apparatus, raceway, **[or]** conduit, **OR SYSTEM** that:

8 (i) generates, transmits, transforms, or uses electrical energy in any
9 form for light, heat, power, or communication; and

10 (ii) is located within a plant, substation, or elsewhere.

11 **(M) “PROVIDE LOW-VOLTAGE ELECTRICAL SERVICES” MEANS TO DESIGN,**
12 **INSTALL, ERECT, REPAIR, MAINTAIN, OR ALTER ANY ELECTRICAL WIRING, FIXTURE,**
13 **APPLIANCE, APPARATUS, RACEWAY, OR CONDUIT THAT:**

14 **(1) FOR AUDIO SIGNAL PROCESSING, AMPLIFICATION, AND**
15 **REPRODUCTION EQUIPMENT, IS OPERATED AT NOT MORE THAN 70 VOLTS-NOMINAL**
16 **OF ELECTRICAL POTENTIAL;**

17 **(2) RELATES TO FIRE ALARM SYSTEMS IN A SINGLE-FAMILY**
18 **RESIDENTIAL DWELLING; OR**

19 **(3) FOR ALL OTHER SERVICES, IS OPERATED AT NOT MORE THAN 50**
20 **VOLTS-NOMINAL OF ELECTRICAL POTENTIAL.**

21 **[(j)] (N)** “State Board” means the State Board of **[Master]** Electricians.

22 **[(k)] (O)** “State license” means a license that is issued by the State Board to **[a**
23 **master]** **AN** electrician.

24 **(P) (1) “VOLTS-NOMINAL” MEANS, FOR ANY ELECTRICAL EQUIPMENT,**
25 **THE STATED VOLTAGE MEASUREMENT AT WHICH THE EQUIPMENT IS DESIGNED TO**
26 **OPERATE.**

27 **(2) “VOLTS-NOMINAL” INCLUDES A RANGE OF ELECTRICAL**
28 **POTENTIAL THAT FOR ANY ELECTRICAL EQUIPMENT IS WITHIN 10 VOLTS BELOW**
29 **AND 10 VOLTS ABOVE THE STATED VOLTAGE MEASUREMENT AT WHICH THE**
30 **EQUIPMENT IS DESIGNED TO OPERATE.**

31 6-102.

1 The [policy of the State] **PURPOSE OF THIS TITLE** is to [regulate, throughout the
2 State, those persons who provide electrical services or engage in the business of providing]
3 **ESTABLISH A LICENSING PROGRAM FOR INDIVIDUALS WHO PROVIDE OR ASSIST IN**
4 **PROVIDING** electrical services, **IN ORDER** to safeguard the life, health, property, and
5 public welfare of the citizens of the State.

6 6–103.

7 (a) This title does not affect the right of any local jurisdiction of the State:

8 (1) to regulate **LOCALLY** the quality and character of work of a person who
9 engages in the business of providing electrical services by establishing a system of licenses,
10 permits, fees, and inspections designed to:

11 (i) ensure compliance with and implementation of State and local
12 building laws; or

13 (ii) enforce other local laws protecting public health and safety;

14 (2) to require a person who engages in the business of providing electrical
15 services to submit any plan or specification for approval before the electrical services are
16 provided;

17 (3) to establish a local board **TO:**

18 **(I) CARRY OUT ITEMS (1) AND (2) OF THIS SUBSECTION;**

19 **(II) TAKE ANY DISCIPLINARY ACTION, EXCEPT FOR**
20 **REVOCAION OF A LICENSE ISSUED BY THE STATE BOARD, AGAINST THE HOLDER**
21 **OF A LOCAL LICENSE OR THE HOLDER OF A LOCAL PERMIT WHO VIOLATES ANY**
22 **PROVISION OF THIS TITLE OR ANY LOCAL LAW; AND**

23 **(III) REPORT ANY ENFORCEMENT ACTIVITY TO THE STATE**
24 **BOARD;**

25 (4) except as provided in §§ 6–504 and 6–602 of this title **AND SUBJECT**
26 **TO THE REQUIREMENTS OF THIS SECTION**, to require an examination before issuing a
27 license to provide electrical services within the local jurisdiction; or

28 (5) to collect, from a person who is licensed with a local board, fees for:

29 (i) an examination for a license to provide electrical services;

30 (ii) issuance and renewal of the license; or

31 (iii) an inspection.

1 (b) If a local jurisdiction licenses any class of electricians other than master
2 electricians **OR JOURNEYPerson ELECTRICIANS**, that class is also under the control and
3 supervision of the local board.

4 (c) (1) **EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,**
5 **BEGINNING JULY 1, 2020, A LOCAL JURISDICTION MAY NOT ISSUE LICENSES FOR**
6 **JOURNEYPerson, LOW-VOLTAGE, OR MASTER ELECTRICIANS.**

7 (2) **A LOCAL JURISDICTION THAT LICENSED**
8 **JOURNEYPerson-LEVEL, LOW-VOLTAGE, OR MASTER-LEVEL ELECTRICIANS**
9 **BEFORE JULY 1, 2020, MAY CONTINUE TO ISSUE THE LICENSES ISSUED BEFORE**
10 **JULY 1, 2020, IF THE LOCAL JURISDICTION COMPLIES WITH SUBSECTIONS (D) AND**
11 **(E) OF THIS SECTION.**

12 (3) (i) **A LOCAL JURISDICTION THAT DID NOT LICENSE**
13 **JOURNEYPerson-LEVEL, LOW-VOLTAGE, OR MASTER-LEVEL ELECTRICIANS**
14 **BEFORE JULY 1, 2020, MAY NOT LICENSE A JOURNEYPerson-LEVEL,**
15 **LOW-VOLTAGE, OR MASTER-LEVEL ELECTRICIAN UNLESS IT APPLIES TO THE STATE**
16 **BOARD FOR AUTHORIZATION TO LICENSE JOURNEYPerson-LEVEL, LOW-VOLTAGE,**
17 **OR MASTER-LEVEL ELECTRICIANS LOCALLY.**

18 (ii) **THE DEPARTMENT SHALL ADOPT GUIDELINES TO GOVERN**
19 **THE AUTHORIZATION BY THE STATE BOARD OF LOCAL JURISDICTIONS TO ISSUE**
20 **LICENSES UNDER THIS PARAGRAPH.**

21 (d) **IF A LOCAL JURISDICTION QUALIFIES TO CONTINUE LICENSING**
22 **JOURNEYPerson-LEVEL, LOW-VOLTAGE, OR MASTER-LEVEL ELECTRICIANS**
23 **UNDER SUBSECTION (C)(2) OF THIS SECTION OR RECEIVES AUTHORIZATION TO**
24 **LICENSE JOURNEYPerson-LEVEL, LOW-VOLTAGE, OR MASTER-LEVEL**
25 **ELECTRICIANS UNDER SUBSECTION (C)(3) OF THIS SECTION, THE LOCAL BOARD**
26 **SHALL ADMINISTER THE SAME EXAMINATION AS THE STATE BOARD AS PROVIDED**
27 **UNDER § 6-306 OF THIS TITLE.**

28 (e) **ON OR BEFORE JULY 1, 2021, AND ON OR BEFORE JULY 1 EACH YEAR**
29 **THEREAFTER, A LOCAL JURISDICTION THAT LICENSES JOURNEYPerson-LEVEL,**
30 **LOW-VOLTAGE, OR MASTER-LEVEL ELECTRICIANS SHALL REPORT TO THE**
31 **DEPARTMENT:**

32 (1) **EACH JOURNEYPerson ELECTRICIAN LICENSE ISSUED IN THE**
33 **PREVIOUS YEAR;**

34 (2) **EACH LOW-VOLTAGE ELECTRICIAN LICENSE ISSUED IN THE**
35 **PREVIOUS YEAR;**

1 **(3) EACH MASTER ELECTRICIAN LICENSE ISSUED IN THE PREVIOUS**
2 **YEAR;**

3 **(4) EACH INDIVIDUAL WHO SAT FOR A JOURNEYPERSON**
4 **ELECTRICIAN EXAMINATION IN THE PREVIOUS YEAR;**

5 **(5) EACH INDIVIDUAL WHO SAT FOR A LOW-VOLTAGE ELECTRICIAN**
6 **EXAMINATION IN THE PREVIOUS YEAR;**

7 **(6) EACH INDIVIDUAL WHO SAT FOR A MASTER ELECTRICIAN**
8 **EXAMINATION IN THE PREVIOUS YEAR; AND**

9 **(7) ANY OTHER INFORMATION THE DEPARTMENT REQUIRES.**

10 **[(c)] (F)** This title may not be construed to waive any requirement of an
11 ordinance or regulation that sets out the type of work to be performed by a person who
12 engages in the business of providing electrical services as required under State or local
13 building laws.

14 **6-104.**

15 **THE DEPARTMENT SHALL ADOPT REGULATIONS TO ESTABLISH THE**
16 **EDUCATION REQUIREMENTS AND QUALIFICATIONS NECESSARY FOR:**

17 **(1) A STATE APPRENTICE ELECTRICIAN LICENSE; AND**

18 **(2) A STATE-REGISTERED APPRENTICE ELECTRICIAN LICENSE.**

19 Subtitle 2. State Board of [Master] Electricians.

20 **6-201.**

21 There is a State Board of [Master] Electricians in the Department.

22 **6-202.**

23 **(a) (1)** The State Board consists of 9 members appointed by the Governor with
24 the advice and consent of the Senate.

25 **(2)** Of the 9 members of the State Board:

26 **(i)** 6 shall be licensed master electricians; [and]

27 **(II) 1 SHALL BE AN ELECTRICAL INSPECTOR;**

1 (III) 1 SHALL BE A LICENSED LOW-VOLTAGE ELECTRICIAN; AND

2 [(ii)] (IV) [3] 1 shall be A consumer [members] MEMBER.

3 (3) Of the 6 master electrician members:

4 (i) 1 shall be from Baltimore City;

5 (ii) 1 shall be from the area that consists of Caroline, Dorchester,
6 Kent, Queen Anne's, Somerset, Talbot, Wicomico, and Worcester counties;

7 (iii) 1 shall be from the area that consists of Baltimore, Cecil, and
8 Harford counties;

9 (iv) 1 shall be from the area that consists of Anne Arundel, Calvert,
10 Charles, **PRINCE GEORGE'S**, and St. Mary's counties;

11 (v) 1 shall be from [the area that consists of] Montgomery [and
12 Prince George's counties] **COUNTY**; and

13 (vi) 1 shall be from the area that consists of Allegany, Carroll,
14 Frederick, Garrett, Howard, and Washington counties.

15 (4) **THE ELECTRICAL INSPECTOR MEMBER SHALL BE FROM THE**
16 **STATE AT LARGE.**

17 (5) **THE LOW-VOLTAGE ELECTRICIAN MEMBER SHALL BE FROM THE**
18 **STATE AT LARGE.**

19 [(4)] (6) The consumer [members] **MEMBER** shall be from the State at
20 large.

21 [(5)] (7) A member of the State Board may not reside in the same county
22 as another member.

23 (c) Each master electrician member of the State Board shall:

24 (1) hold an active [State] **AND CURRENT** license **UNDER THIS TITLE**; and

25 (d) [Each] **THE** consumer member of the State Board:

26 (1) shall be a member of the general public;

27 (2) may not be a licensee or otherwise be subject to regulation by the State
28 Board;

1 (3) may not be required to meet the qualifications for the professional
2 members of the State Board; and

3 (4) may not, within 1 year before appointment, have had a financial
4 interest in or have received compensation from a person regulated by the State Board.

5 (e) While a member of the State Board, [a] THE consumer member may not:

6 (1) have a financial interest in or receive compensation from a person
7 regulated by the State Board; or

8 (2) grade an examination given by or for the State Board.

9 (h) (2) Except as provided in paragraph (3) of this subsection and subject to
10 paragraph (4) of this subsection, a member shall be considered to have resigned if the
11 member did not attend at least two-thirds of the STATE Board meetings held during any
12 consecutive 12-month period while the member was serving on the STATE Board.

13 6-205.

14 (A) In addition to any powers and duties set forth elsewhere, the State Board
15 shall:

16 (1) twice a year hold a seminar and invite members from each local
17 licensing jurisdiction to discuss any industry or licensing problems; [and]

18 (2) adopt regulations to establish:

19 (i) application and examination fees;

20 (ii) continuing education requirements; and

21 (iii) application deadlines;

22 (3) ENFORCE, WITHIN 18 MONTHS OF ISSUANCE, MINIMUM
23 STANDARDS FOR THE PROVISION OF ELECTRICAL SERVICES CONSISTENT WITH THE
24 MOST RECENTLY ISSUED VERSION OF THE NATIONAL FIRE PROTECTION
25 ASSOCIATION 70: NATIONAL ELECTRICAL CODE;

26 (4) ISSUE LICENSES;

27 (5) KEEP RECORDS OF ITS PROCEEDINGS; AND

28 (6) ADOPT ANY OTHER REGULATIONS NECESSARY TO CARRY OUT
29 THIS TITLE.

1 **(B) THE CONTINUING EDUCATION REQUIREMENTS ADOPTED UNDER THIS**
2 **SECTION SHALL:**

3 **(1) BE BASED ON THE NATIONAL ELECTRICAL CODE OR ANY LOCAL**
4 **VARIANTS ADOPTED BY A LOCAL BOARD;**

5 **(2) CONSIST OF A COURSE OR TRAINING ON PRACTICAL TECHNIQUES,**
6 **INSTALLATION PROCEDURES, OR OTHER RELEVANT TOPICS; AND**

7 **(3) BE ADMINISTERED BY:**

8 **(I) A COLLEGE OR AN APPRENTICESHIP PROGRAM APPROVED**
9 **BY THE MARYLAND APPRENTICESHIP AND TRAINING COUNCIL OR THE FEDERAL**
10 **COMMITTEE ON APPRENTICESHIP;**

11 **(II) A STATE OR NATIONALLY RECOGNIZED TRAINING**
12 **PROGRAM; OR**

13 **(III) ANOTHER PERSON APPROVED BY THE STATE BOARD.**

14 6–301.

15 (a) Each county shall:

16 (1) **(I) adopt regulations that have qualifications [comparable to] THAT**
17 **ARE AT LEAST AS STRINGENT AS THE QUALIFICATIONS UNDER § 6–304 of this subtitle,**
18 **to provide for the licensing and regulation of master electricians OR JOURNEYPERSON**
19 **ELECTRICIANS; AND**

20 **(II) 1. APPLY TO AND RECEIVE AUTHORIZATION FROM THE**
21 **STATE BOARD TO LICENSE JOURNEYPERSON ELECTRICIANS OR MASTER**
22 **ELECTRICIANS IF REQUIRED TO DO SO UNDER § 6–103 OF THIS TITLE; or**

23 **2. CONTINUE ISSUING JOURNEYPERSON ELECTRICIAN**
24 **OR MASTER ELECTRICIAN LICENSES IF THE COUNTY QUALIFIES UNDER §**
25 **6–103(C)(2) OF THIS TITLE TO CONTINUE ISSUING LOCAL LICENSES; OR**

26 (2) (i) require a State license for providing electrical services as a
27 master electrician **OR JOURNEYPERSON ELECTRICIAN; and**

28 (ii) enforce the provisions of this title.

29 (b) Each municipal corporation shall:

1 (1) **(I)** adopt regulations that have qualifications [comparable to, or
2 more stringent than,] **THAT ARE AT LEAST AS STRINGENT AS THE QUALIFICATIONS**
3 **UNDER § 6–304** of this subtitle to provide for the licensing and regulation of
4 **JOURNEYPERSON OR** master electricians; **AND**

5 **(II) 1. APPLY TO AND RECEIVE AUTHORIZATION FROM THE**
6 **STATE BOARD TO LICENSE JOURNEYPERSON ELECTRICIANS OR MASTER**
7 **ELECTRICIANS AS REQUIRED TO DO SO UNDER § 6–103 OF THIS TITLE; OR**

8 **2. CONTINUE ISSUING JOURNEYPERSON ELECTRICIAN**
9 **OR MASTER ELECTRICIAN LICENSES IF THE MUNICIPAL CORPORATION QUALIFIES**
10 **UNDER § 6–103(C)(2) OF THIS TITLE TO CONTINUE ISSUING LOCAL LICENSES;**

11 (2) adopt the electrical rules and regulations of the county in which the
12 municipal corporation is located; or

13 (3) (i) require a State license for providing electrical services as a
14 **JOURNEYPERSON OR** master electrician; and

15 (ii) enforce the provisions of this title.

16 (c) Each licensed master electrician shall display the State license number [or],
17 the county license number, **OR THE MUNICIPAL CORPORATION LICENSE NUMBER** of the
18 licensee on each vehicle used on the job for providing electrical services.

19 (d) A county or municipal corporation may not adopt a resolution or enact a law
20 that requires a person licensed under this subtitle who is compliant with subsection (c) of
21 this section to display additional license numbers on each vehicle used on the job for
22 providing electrical services.

23 6–302.

24 (a) In a local jurisdiction that requires a local license **AND HAS QUALIFIED TO**
25 **CONTINUE ISSUING LOCAL LICENSES UNDER § 6–103(C)(2) OF THIS TITLE OR**
26 **RECEIVED AUTHORIZATION FROM THE STATE BOARD UNDER § 6–103 OF THIS TITLE,**
27 the State license, while the State license is in effect, serves only as a mechanism that helps
28 a licensee in obtaining a local license under §§ 6–601 and 6–602 of this title.
